# **DIRECTIONS:**

## **MIXING INSTRUCTIONS:**

Shake the ECG Mosquito Wall container well before mixing. For each gallon of water, add:

- 8 teaspoons for light infestations
- 16 teaspoons for heavy infestations
   Mix thoroughly. Use warm water if available.

For hose-end sprayers, fill the bottle halfway with ECG Mosquito Wall and the rest with water.

Set the dial to 2 ounces per gallon, or 12 teaspoons per gallon.

If there's no dial, use 20 ounces of ECG Mosquito Wall and fill the rest with water.

NOTE: The product is formulated to remain gentle on plants and animals, even if applied at higher-than-recommended levels.

### **APPLICATION INSTRUCTIONS:**

TIMING: Spray between 8-11 AM or 5-7 PM. Avoid midday heat, wind, and rain within 24 hours.

AREAS: Use a heavy mist on grass, ornamentals, flowers, vegetables, trees (cover lower limbs), and any standing water. Thoroughly cover all foliage, including the undersides of leaves. Use any leftover spray to reapply.
